

**THE BOROUGH OF NEW EAGLE COUNCIL MEETING**  
**FEBRUARY 10, 2026**

The Borough of New Eagle Council met at 5:30 p.m. on February 10, 2026, at the New Eagle Borough Municipal Building, 157 Main Street, New Eagle PA 15067.

The Pledge of Allegiance was recited, call of the roll was taken by the Borough Secretary K. Koontz. There being a quorum present the meeting was called to order by Council President T. Chaney.

Minutes from the previous meeting was presented to Council for approval. The motion to approve the minutes was made by B. Koziel and seconded by D. Guarino. The motion was carried by call of the roll by the Secretary. B. Williams abstained due to not being in attendance for the January meeting.

The motion to approve and pay bills in the amount of \$24,985.59 was made by B. Williams and seconded by B. Koziel. Motion was carried by the unanimous call of the roll by the Secretary.

Committee Reports: A motion was made by T. Chaney and seconded by B. Williams to appoint Bill Sherry to the Ambulance Board.

Mayor W. Sherry declared an Emergency Disaster Declaration on January 26, 2026, in response to the severe winter weather storm that impacted our community.

New Business:

The motion was made by D. Guarino and seconded by B. Koziel to approve T. Chaney, B. Williams and B. Koziel as signatories on the Borough's accounts payable. Granting them authority to sign checks on behalf of the Borough. The motion was carried by unanimous call of the roll by the Secretary.

The motion was made by D. Guarino and seconded by B. Koziel to approve the installation of an LED sign for Riverview Baptist Church, 405 Main Street, New Eagle, contingent upon PennDOT's approval of the application. Final authorization shall be granted only upon receipt of PennDOT's written approval. The motion was carried by unanimous call of the roll by the Secretary.

The motion was made by B. Williams and seconded by B. Koziel to approve Resolution NO.1-2026 Borough of New Eagle, Washington County, Commonwealth of Pennsylvania setting the Tax Collector's Bond amount at \$122,844.05. The motion was carried by unanimous call of the roll by the Secretary.

The motion was made by T. Chaney and seconded by D. Guarino to approve the revised Standard Operation Procedure for the Public Works Department, effective February 10, 2026. The motion was carried by unanimous call of the roll by the Secretary.

The motion was made by T. Chaney and seconded by B. Williams to table the motion to accept and approve the Addendum to Articles of Agreement between the City of Monongahela and the Borough of New Eagle for police protection. Motion to table was carried out by unanimous call of the roll by the Secretary.

No further business was discussed, motion to adjourn the meeting at 5:54 p.m. was made by B. Koziel and seconded by D. Guarino. Motion carried by unanimous call of the roll by the Secretary.
