REORGINIZATIONAL/COUNCIL MEETING JANUARY 5, 2026

The Borough of New Eagle Council met in executive session after the regular meeting on January 5, 2026, for personnel matters.

The Borough of New Eagle Council met on Tuesday, January 5, 2026, for reorganization. The reorganizational meeting was called to order by Mayor W. Sherry with the following Council members present T. Chaney, W. Sherry, D. Walters and via phone B. Williams. Also present was Solicitor T. Berggren. There being a quorum present the meeting was called to order.

The three newly elected Council members, P. Pro, D. Guarino, B. Koziel were sworn to their Oaths of Office by Solicitor T. Berggren.

Mayor W. Sherry called for nomination for President of Council. T. Chaney nominated herself as President, seconded by B. Williams. Motion was carried out by unanimous call of the roll by the Secretary.

Mayor W. Sherry called for nominations of Vice President of Council. The motion was made by D. Guarino and seconded by B. Koziel to nominate P. Pro. Motion was carried out by unanimous call of the roll by the Secretary.

Mayor W. Sherry adjourned the reorganizational meeting.

The regular meeting session was called to order by President T. Chaney.

Visitor: Chuck Koval, 725 Sycamore Street, New Eagle. He is requesting that the South portion of 4<sup>th</sup> Avenue off Sycamore continues to have snow removal. In the past two years it has not been maintained. Mr. Koval said that he was informed by Public Works Foreman K. Behanna he was instructed not to plow that area by the former Public Works Foreman. Moving forward this area will be plowed.

The minutes from the December 10, 2025, meeting were presented to Council for approval. The motion to approve the minutes as presented was made by P. Pro and seconded by B. Koziel. Motion was carried out by unanimous call of the roll by the Secretary.

The bills in the amount of \$62,588.37 were presented to Council for approval. The motion was made by P. Pro and seconded by B. Koziel. Motion carried by unanimous call of the roll by the Secretary.

New Business: The motion to appoint Dorene Zavarello to the New Eagle Municipal Sewage Board to a four-year term commencing January 1, 2026, through December 31, 2030, was made by B. Williams and seconded by D. Guarino. Motion was carried out by unanimous call of the roll by the Secretary.

The motion to approve and grant permission for the installation of a 5 ½ foot by 21 inches LED sign at the New Eagle Volunteer Fire Department, 165 Main Street, New Eagle contingent upon receiving all required approvals from PennDot was made by D. Guarino and seconded by B. Koziel. Motion was carried out by unanimous call of the roll by the Secretary.

The motion to extend the current refuse contract with Noble Environmental (County Hauling) for a one-year extension from January 1, 2026, through December 31, 2026, was made by T. Chaney and seconded by D. Guarino. Motion was carried by unanimous call of the roll by the Secretary.

No further business was discussed motion to adjourn the meeting at 5:55 was made by P. Pro and seconded by D. Guarino. Motion was carried by unanimous call of the roll by the Secretary.
